

## **Grand opening of PRIME Corporate Center**

PRIME Corporate Center in Warsaw, an office building located at Grzybowska 78, was officially opened on 26 April. The celebration was attended by representatives of the investor Golub GetHouse and the sole tenant Raiffeisen Polbank, as well as the architects and contractors who contributed to the construction. Raiffeisen Polbank's new headquarters will provide working space for approx. 2 100 employees.

The construction of PRIME Corporate Center, with nearly 20 900 sqm of leasable space, was finalized in March. The general contractor of PRIME Corporate Center was Warbud, which completed construction on schedule, within just two years since its beginning. The building has been designed by Solomon Cordwell Buenz architecture office from Chicago that cooperated with Epstein Warsaw office. The office building is BREEAM "Very good" certified.

The opening ceremony gathered hundreds of guests, including the management and employees of Raiffeisen Polbank, representatives of the developer, Mr Eugene Golub president of the Management Board of Golub & Company, members of the architects' studio, and representatives of the new owner of the building.
