

## WeWork in Mennica Legacy Tower

**WeWork, flexible workspace provider, has become the sole tenant of office space in the Western Building of the Mennica Legacy Tower – the modern office complex being built by Golub GetHouse and Mennica Polska S.A. at the junction of Prosta and Żelazna streets in Warsaw.**
